Trophy Quest Outdoors assumes no liability for any loss, expense, damage, accident, delay, inconvenience, injury or death which results directly or indirectly from the drawing of any permits and any resulting hunting and related activities, whether successful, that may be undertaken. Applicant agrees to be responsible for the costs should a license be drawn. Applicant agrees that he/she will be responsible for payment of all license fees should a tag successfully be drawn. Any adult who witnesses an Application Form for a minor will assume all liabilities and fees for said minor. Entirety: This instrument sets forth the entire agreement between Trophy Quest Outdoors and applicant. Should any provision of this Agreement be void or unenforceable, the rest of this Agreement shall remain in full force. This Agreement may not be canceled, altered, or amended except in writing. Choice of Law: Any disputes which may arise between Trophy Quest Outdoors and the applicant agrees provided herein shall be heard solely in the appropriate state or federal court located within the State of Utah and in no other jurisdiction.
